
IN THE BOX

- WLT-IL25 Illume Rechargeable Touch-Control Mini Desk Lamp (x1)
- Lamp Base (x1) • Lamp Post (x2) • Charging Cable (x1)

SAFETY PRECAUTIONS

- This product is NOT a toy, keep away from children and pets.
- Only use the device according to the instructions in this manual. Never use the device for anything other than its intended purpose.
- Do not open this product or attempt to repair the unit yourself if it is not working properly. Doing so risks fire, shock or injury.
- When not in use, the device should be stored in a dry, cool location, away from sources of water or heat.
- Do not expose device or charging cable to extreme temperatures (heat or cold), open flames, humid or wet conditions.
- Do not submerge in water. Do not use in a location where the device or charging cable could fall into liquid.
- Unplug the charging cable when not in use. Do not pull the charging cable to disconnect, or use the cable as a handle.
- Do not use if device or charging cable is damaged. If device or charging cable is damaged, it **MUST** be serviced or replaced by the manufacturer or its service agent before using again.
- Low battery may cause dysfunction.
- Do not over charge battery.

INSTRUCTIONS

Be sure to fully charge the light before using for the first time.

CHARGING THE LIGHT

- Plug the small connector of the included charging cable into the USB -C charging port on the light.
- Plug the large connector into a USB power source, such as the USB port on a computer or into a compatible 5V USB adapter (not included) and plug into a wall socket.
- The LED indicator will **glow RED** when charging and **turn GREEN** when fully charged.

ASSEMBLING & USING THE LIGHT

- Assemble the 2 lamp posts by inserting one lamp post into the screw hole of the other one and turning it clockwise until it is fully tightened.
- Install the lamp post to the base by inserting the base into the screw hole of the lamp post and turning it clockwise until it is fully tightened.
- Install the lamp to the base by inserting the lamp into the screw hole of the lamp post and turning it clockwise until it is fully tightened.
- Touch the **Power button** to turn light ON.
- Touch the **Power button** to adjust brightness level of the light and to **turn OFF**.
- Turn the light OFF when it's not in use.
